

## **DESKTOP LICENSE AGREEMENT**

THIS AGREEMENT IS BY AND BETWEEN JOINT STOCK COMPANY PROGNOZ (HEREINAFTER REFERRED TO AS THE "LICENSOR"), ON THE ONE PART, AND ANY NATURAL PERSON OR LEGAL ENTITY ENTITLED AND AUTHORIZED TO SIGN AND FULFIL THIS DESKTOP LICENSE AGREEMENT (HEREINAFTER REFERRED TO AS THE "LICENSEE"), ON THE OTHER PART, HEREINAFTER COLLECTIVELY REFERRED TO AS THE PARTIES.

BY ACCEPTING TERMS AND CONDITIONS OF THIS DESKTOP LICENSE AGREEMENT (HEREINAFTER THE "AGREEMENT") BY DOWNLOADING, INSTALLING, ACCESSING AND/OR USING IN ANY MANNER WHATSOEVER THE DESKTOP SOFTWARE, THE LICENSEE COVENANTS TO PERFORM THE OBLIGATIONS HEREUNDER. IF THE LICENSEE DOES NOT AGREE WITH THE REQUIREMENTS HEREUNDER, THE CURRENT VERSION OF THE AGREEMENT OR DEFINITIONS USED IN IT, THE LICENSEE MAY NOT DOWNLOAD, INSTALL, ACCESS AND/OR USE THE DESKTOP SOFTWARE.

The Licensor shall reserve the right to amend or supplement the Agreement. Any amendments or supplements shall become effective once made. The current version of the Agreement shall be located at <a href="http://www.prognoz.com/sites/default/files/demoexamples/license">http://www.prognoz.com/sites/default/files/demoexamples/license</a> agreement.pdf. The Licensee shall read the current version of the Agreement. If the Licensee does not agree with terms and conditions of the Agreement, the Licensee shall cease all use of the Desktop Software.

The Licensor shall reserve the right to revise, modify or delete any Desktop Software components at any time and without prior notice.

### **DEFINITIONS**

"Software" means the Prognoz Platform 8 computer program. The Licensor is the holder of the Prognoz Platform 8 computer program.

"Desktop Software" means a version of the Prognoz Platform 8 computer program, except individual functions that can be modified or disabled at the election of the Licensor and without notice. The composition and functionality of the Desktop Software may reflect no updates of the Software made from the release of the Desktop Software.

"User" means any natural person who committed to abide by terms and conditions hereunder and uses the Desktop Software for own needs, or an employee of the Licensee's legal entity who is directly subordinate to the Licensee under a labor contract. For the purpose of this Agreement, the terms "User" and "Licensee" shall be deemed interchangeable.

"Personal Computer" means a computer intended for the private use of a single User.

"File Server" means a server designed to store and exchange files, and to perform file input/output operations.

"Information" means data from public sources loaded in a desktop software and used exclusively for the purpose of demonstrating the Desktop Software functionality.

"License" means the right to use the Desktop Software subject to terms and conditions hereunder.

# 1. GRANT OF LICENSE

- 1.1 The Licensor shall grant to the Licensee the free nonexclusive, nontransferable License for the use of the Desktop Software for promotion purposes to the extent as described in Section 1.2 hereof for the period specified in Section 3.1 hereof.
- 1.2 The Licensor shall grant to the Licensee the right to use the Desktop Software to the extent as follows:
  - 1.2.1 Download, install, and reproduce one copy of the Desktop Software on one Personal Computer.
  - 1.2.2 Use the Desktop Software solely for the Licensee's personal or internal business use for evaluating functionality of the Desktop Software. The use of the Desktop Software for any commercial purposes, competitive analysis or other purposes not expressly specified herein shall be prohibited.

#### 2. RESTRICTIONS

## 2.1 The Licensee may not:

- 2.1.1 Transfer the rights hereunder to any natural persons and/or legal entities who are not the Licensee's employees.
- 2.1.2 Install the Desktop Software components on additional Personal Computers, File Servers, or other hardware.
- 2.1.3 Customize hardware and/or software so as to connect more than one User to the Desktop Software. The maximum number of Users entitled to access the Desktop Software at any time shall not exceed one User.
- 2.1.4 Copy, reproduce, publish, distribute, sublicense, transfer, rent, and lease the Desktop Software.
- 2.1.5 Offer, use, sublicense or otherwise commercially exploit any of the Desktop Software, including without limitation use of the Desktop Software as a revenue-generating (or value enhancing) product or service to any third party, for third party training, or to provide hosting, service bureau, commercial time-sharing, rental, or software as a service (SaaS) services to third parties who are not Licensees for the purposes of providing those persons or entities with use of the Desktop Software;
- 2.1.6 Permit the use of the Desktop Software by third parties or use the Desktop Software on any online collaboration platform which is not sponsored by Licensor;
- 2.1.7 Use the Desktop Software for purposes of benchmarking, collecting and publishing performance data, or developing a product which is competitive with any Licensor's product or services;
- 2.1.8 Modify, reverse compile, reverse assemble the Desktop Software.
- 2.1.9 Make derivative or composite works of the Desktop Software, as well as include the Desktop Software in part or in full in other works.
- 2.1.10 Alter, edit, and delete the Licensor's trademarks.
- 2.1.11 Copy, reproduce, and disseminate Information.

2.1.12 Use Information for purposes not related to the use of the Desktop Software.

If the Licensee breaches the provisions of Section 2.1, the Licensor in addition to losses incurred may impose a penalty on the Licensee at the rate of 100,000 (One hundred thousand) rubles for each breach as described in Section 2.1.

- 2.2 The Licensor shall bear responsibility for the Desktop Software compatibility with any Licensee's hardware and software.
- 2.3 The Licensor shall bear no responsibility for the use by the Licensee of the Information utilized in the Desktop Software. The Licensor shall also bear no responsibility for the accuracy and actuality of the Information.
- 2.4 In no event the Licensor shall give any guarantees and be liable for any losses, including loss of data, loss of profits, and other incidental, consequential and indirect damages arising from acts of the Licensee on the installation and use of Desktop Software or from unauthorized modifications of the Desktop Software components causing temporary inoperability or failure of the Licensee's hardware, software or data.
- 2.5 In case of any claim against the Licensor caused by the use of the Desktop Software or Information by the Licensee, the Licensee shall immediately assume such claim and indemnify any losses incurred by the Licensor as the result of such claim, and at its expense and at its sole risk shall take immediate actions to settle the claim, including in a judicial procedure, take part in the claim proceedings, including in court.

#### 3. TERMINATION OF THE AGREEMENT

- 3.1 This Desktop License Agreement is effective until terminated.
- 3.2 The Licensee may terminate this Desktop License Agreement for convenience at any time by uninstalling, destroying or returning to Licensor all copies of the Desktop Software in the Licensee's possession or within its control. Licensor may terminate this Desktop License Agreement immediately upon Licensee's breach.
- 3.3 This Desktop License Agreement can be terminated by Licensor by publishing of the corresponding announcement on the electronic address <a href="http://www.prognoz.com/sites/default/files/demoexamples/license\_agreement.pdf">http://www.prognoz.com/sites/default/files/demoexamples/license\_agreement.pdf</a>. Licensee has to control the status of the present Desktop License Agreement. After publishing of the abovementioned announcement of termination of this Desktop License Agreement, Licensee has to terminate the use of the Desktop Software and uninstall of destroy the Desktop Software.

#### 4. FINAL PROVISIONS

4.1. This License Agreement shall be governed by the laws of the Russian Federation.
